Newcastle International Airport Draft Masterplan 2030

I am delighted to attach a summary of our draft masterplan, which outlines development aspirations for the airport up to 2030. We recently launched a major consultation exercise and we would very much welcome any comments, suggestions or support you might wish to give.

In order to provide an improved airport, encourage new routes and attract new customers, we need to develop additional infrastructure and customer facilities. By preparing our masterplan, we hope to manage the impacts of future expansion on the environment, our local community and the ground transport network.

The developments outlined in the masterplan have the potential to generate very significant benefits for the North East. By the end of the plan period, the airport will support up to 10,000 jobs across the region with a potential additional 2,150 jobs as a result of proposed business parks to the south of the runway. By 2030, overall contribution to the regional economy could reach up to £1.3 billion.
